

# **Athene Product Training**

PLEASE NOTE: Product training must be completed by ALL agents before writing business. Product training is required for all agents prior to selling Ascent Accumulator with its new optional legacy rider. If you have already completed training for Ascent Pro, you have met the requirement for the enhanced Pro products. If you have already completed the training for Athene MYG, you have met the requirement for Athene MaxRate.

**Texas Resident Agents**: Athene requires Texas resident agents to complete eight hours of annuity training during each licensing period. Additionally, Athene requires a current four-hour annuity training to be completed during the current period prior to an application being taken in Texas. If you are taking your initial training, Athene requires that you have eight hours of initial training prior to writing any business.

**Texas Non-Resident Agents**: Athene requires Texas non-residents to complete a Cert approved course from Sircon for Texas not a CE course.

**Athene New York Max Rate Product**: Athene requires ALL agents complete the new 2017 training course prior to writing business.
